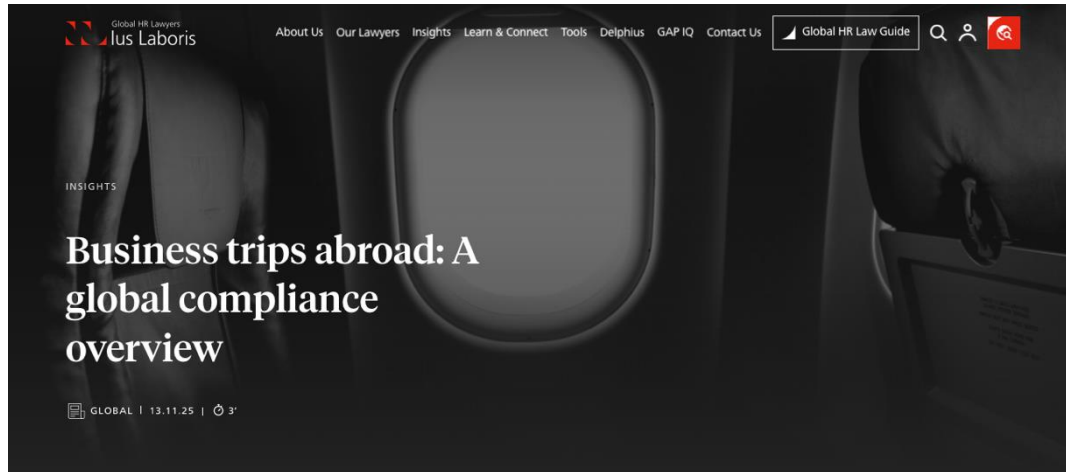

Czech Republic	
The essentials	
Visa required and duration of stay	A business (trade) trip visa is sufficient for specified business trip-related activities. This entitles visitors to stay for a maximum of 90 days within a period of 180 days. Short-term work (employment) activities require a different type of Schengen visa for the purpose of "other (employment)" along with a work permit.
Permitted activities	Business meetings, business negotiations, contract conclusion, order placement, trade fair attendance and other business-related reasons.
Additional requirements / considerations	
Social security confirmation	This is strongly recommended.
Prior notice / authorisation of trip	Only in connection with obtaining a visa. Otherwise, this is not required.
Application of local employment rights	In the case of the posting of workers, only certain selected Czech working conditions apply, if more beneficial, for a period of 12 months. This period can be prolonged, based on prior notification, to 18 months. After this period, as a rule, all local working conditions apply to the posted employee, if they are more beneficial. In other cases (i.e. other than posting), generally speaking, only overriding mandatory provisions apply.
